**The Obliteration Doctrine** Dan Steinbock, 2025-08-01 The Obliteration Doctrine tackles the deadliest canon of 21st century warfare. It addresses the abject devastation that this military doctrine has wrought, how it was done and those responsible. It puts the Genocide Convention's failure to punish and prevent this crime under close scrutiny. The Obliteration Doctrine combines lethal forms of warfare—scorched-earth military tactics, collective punishment and civilian victimization—with indiscriminate area bombing and counterinsurgency operations. What's new about this form of warfare is the chilling mix of artificial intelligence and genocidal atrocities in violation of international law, the very foundations of international society and all human life. This book shows how the doctrine's implementation in Gaza was facilitated by the United States, with Germany, the UK, Italy and Canada as strategic partners. While Israel pulled the trigger in Gaza, the weaponry and financial and diplomatic support came from the US-led West. Hence their complicity in the fatal carnage. The rise of this deadly doctrine has been enabled by the West's long opposition to genocide prevention, which Raphael Lemkin's quest for effective legislation failed to overcome. Fearful of its vulnerability, the West succeeded in excluding and diluting core parts of the Genocide Convention addressing colonial atrocities, cultural genocide, political killings, and ethnic cleansing. Enforcement was repressed throughout the Cold War, and the few tribunals afterward soon proved inadequate. The West undermined genocide prevention by shunning preparatory attacks, early warnings and incitement prosecution. Ex post facto justice records but doesn't preempt genocides. Stunningly, the Obliteration Doctrine was largely perfected institutionally by Israel two decades before October 7, 2023, yet the international community failed to prevent its further implementation, which its proponents openly pledged to deploy in the "next war." That said, a broad variety of legal efforts have been launched against Israel and its complicit Western allies in international and domestic courts by many activists and countries increasingly in and by the Global South. The erasure of Gaza reflects the tragic inability of the Genocide Convention to prevent the genocides it was created to identify, preempt and punish. The Obliteration Doctrine has set a horrendous precedent, providing a template for new and far worse "final solutions" to be unleashed on entire nations.

**Disaster Nationalism** Richard Seymour, 2024-10-29 Liberal civilisation is in crisis - now is a time of monsters. **Christ in the Rubble** Munther Isaac, 2025-03-27 A cry from the heart and a call to action from a Palestinian Christian pastor and theologian In this impassioned and incisive book, Munther Isaac challenges mainstream Christians' uncritical embrace of the modern State of Israel. **Fanon, Žižek, and the Violence of Resistance** Zahi Zalloua, 2025-06-26 In a novel pairing of anti-colonial theorist Frantz Fanon with Marxist-Lacanian philosopher Slavoj Žižek, Zahi Zalloua explores the ways both thinkers expose the violence of political structures. This inventive exploration advances an anti-racist critique, describing how ontology operates in a racial matrix to produce some human bodies that count and others (deemed not-quite- or non-human) that do not. For Fanon and Žižek, the violence of ontology must be met with another form of violence, a revolutionary violence that delegitimizes the logic of the symbolic order and troubles its collective fantasies. Whereas Fanon begins his challenge to ontology by exposing its historical linkages to Europe's destructive imperialist procedures before proceeding to stretch Marxism, along with psychoanalysis, to account for the crushing (neo)colonial situation, Žižek premises his work on the refusal to accept the totality of ontology. Because of these different points of intervention, Fanon and Žižek together offer a powerful and multifaceted assessment of the liberal anti-racist paradigm whose propensity for identity politics and aversion to class struggle silence the cry of the dispossessed and foreclose radical change. Avoiding contemporary separatist temptations (decoloniality and Afropessimism), and breaking with a non-violent, sentimentalist futurology that announces more of the same, Fanon and Žižek point in a different direction, one that eschews identitarian thought in favor of a collective struggle for freedom and equality.

For over 30 years, Professor Władysław Czapliński has been professionally associated with the Institute of Law Studies of the Polish Academy of Sciences, where he served as Director from 2004 to 2016, and where his most important works were written. It aims to capture the breadth of his interests and the depth of his scholarship. The essays within, written in English, French and Polish, are contributions from his colleagues, friends and former students. Many authors raise general, classic questions

of international law: the foundations of the contemporary international legal order (Stephan Hobe and María Isabel Torres Cazorla), jus cogens (Maurizio Arcari and Beatrice Bonafé), customary international law (Chun-i Chen), the general principles of law (Artur Kozłowski and Monica Lugato), the fragmentation of international law (Ewelina Cała-Wacinkiewicz), neutrality (Michał Kowalski), force and its use in international law (Dino Kritsiotis), formal sources of the protection of international human rights (Roman Kwiecień), the art of interpreting treaties (Anna Wyrozumska), recognition (Brad R. Roth), non-contractual liability of the State (Maja Seršić) and compensation schemes in international law (Pavel Šturma). Other authors in turn raise the issue of international justice. Wojciech Sadowski refers to a general problem of separate opinions, whilst other texts deal with the functioning and case law of the International Court of Justice (ICJ), the European Court of Human Rights (ECtHR) and the International Criminal Court (ICC): locus standi before the ICJ (Patrycja Grzebyk), interim measures implemented by the ICJ (Peter Hilpold), obligations of States in the context of the crime of genocide in the case law of the ICJ (Karolina Wierczyńska and Szymon Zaręba), the international responsibility of States under the European Convention on Human Rights (Michał Balcerzak), the right to cultural heritage in the case law of the ECtHR (Andrzej Jakubowski), the possibility of denouncing the ECHR (Ireneusz Kamiński), interim measures adopted by the ECtHR (Bernard Łukańko) and the application of international law by the ICC (Peter Kovács). **The Fall of Israel** Dan Steinbock,2025-01-01 The path to the obliteration of Gaza was paved by the confluence of a set of longstanding forces. In the Gaza War, these ties fostered paradigms of devastation, such as the Dahiya doctrine and mass assassination factories, backed by pioneering artificial intelligence. The settlements have contributed to the destabilization of the broader region since the early 1970s, and are now compounding its politico-economic and geopolitical crisis. This book addresses the efforts to institute a Jewish rather than a secular state. It shows how the postwar labor alignments were replaced by the hard-right coalitions, thanks to U.S. neoliberal economic policies, assertive neoconservatism and Jewish-American donors. It also explains the causes behind the rise of the Messianic far-right, centrist parties, and the failure of the Left. The corrosion of Israeli society and politics was already reflected in and driven by



an economy constrained by adverse erosion, as reflected by the liabilities of its high-tech cluster, the talent “brain drain,” the threatened welfare state and subsidized religious sector. But now, the already evident politico-economic costs to Israel of the Gaza war have set the stage for extraordinary uncertainty in the foreseeable future.
